Winter Averaging - What To Know



Winter Averaging is a common practice in utility billing. It involves calculating an average based on your water consumption during winter, specifically November through February, which will determine your wastewater charge for the next 12 months.

The reasoning behind this approach is that during these winter months, outdoor water usage (e.g., watering lawns and gardens and washing your car in the driveway) is generally lower due to colder weather. Therefore, the winter months are considered a fair representation of residential wastewater use. The wastewater charge on your bills will be calculated using this average to determine a fixed amount, regardless of actual wastewater flow during the billing period.

It's important to remember that Winter Averaging only applies to wastewater billing. You will continue to be billed for potable water consumption based on your actual usage throughout the year.


