2024 - 2025 Block House MUD Tax Rate The levy of the district tax rate is a two-step process that is done in conjunction with adopting the district's budget



Each year, the District undertakes due diligence to ensure that the District's budget addresses the operation and maintenance needs of the District. Such expenditures include the maintenance of the District's water and wastewater systems, park and pool operation and maintenance, and the maintenance of the District's amenities

After the District's Board of Directors un-

derstands the budget considerations, a proposed O&M (operations and maintenance) tax rate is established. At the same time, the Board also undertakes diligence relating to the I&S (debt service) tax rate and the fire tax rate. The Board then formally meets to approve a proposed tax rate, and subsequent to such approval, the proposed tax rate is published in a newspaper of general circulation.

After publication, the Board once again formally meets in the context of an official meeting and conducts a public hearing relating to the tax levy. The Board levies the tax rate after the public hearing and further deliberation. As a local government entity of the State of Texas, the District must adopt its tax rate annually in accordance with all applicable state laws. In 2023, the District levied a total tax rate of \$0.5905/\$100 assessed valuation; in 2024. the District levied a total tax rate of \$0.5504/\$100 assessed valuation.

Please ensure your firearms are locked and stored safely at home, in your car, or anywhere else.

Taking these precautions helps prevent these dangerous weapons from falling into the wrong hands and keeps the community safe.

WINTER AVERAGING

It's important to remember that Winter Averaging only applies to wastewater billing. You will continue to be billed for potable water consumption based on your actual usage throughout the year, and this occurs for Block House MUD this year from November 28, 2024, to February 28th, 2025

Winter Averaging is a common practice in utility billing. It involves calculating an average based on your water consumption during winter, specifically November through February, which will determine your wastewater charge for the next 12 months.

The reasoning behind this approach is that during these winter months, outdoor water usage (e.g., watering lawns and gardens and washing your car in the driveway) is generally lower due to colder weather. Therefore, the winter months are considered a fair representation of residential wastewater use. The wastewater charge on your bills will be calculated using this average to determine a fixed amount, regardless of actual wastewater flow during the billing period.
