CD&P PROPOSAL FOR BLOCK HOUSE CREEK MUD SERVICES

VISIONING & GOALS WORKSHOP

CD&P will facilitate a 2 to 3 hour workshop for board members and staff to unite around shared visions and goals for the organization. During this workshop, we will focus on the following objectives:

- Strengths Weaknesses Opportunities and Threats exercise
- Outlining issues and objectives
- Prioritizing objectives
- Planning for resident communications

Deliverables: preparation, facilitation, and reporting on one 2 to 3 hour workshop

COMMUNITY SURVEY

CD&P will develop a survey to gather community feedback on communication preferences, park bond project priorities, satisfaction with the MUD/Board, and to gather input on concerns and opportunities for the future. The survey will be distributed electronically and paper copies will be made available on request. CD&P will assist the MUD in promoting survey participation. Promotional tools may include: social media posts, email reminders, signage, and postcards. Survey responses will be verified by name and address to allow one survey per household.

Deliverables: development of survey with up to 2 rounds of revisions, identification of the survey tool and build out of final survey, promotion of the survey, verification of surveys, and a final report.

QUARTERLY NEWSLETTERS

We will design and distribute up to 4 quarterly electronic newsletters for a variety of audiences. These will incorporate feature stories, service updates, photos, and infographics to convey information to key audiences. E-newsletters can be tracked for clicks, opens, and forwards. This budget accounts for up to 6 hours of photography of community events and/or sites.

For budgeting purposes, we assumed the MUD had an email distribution tool (Constant Contact, Mail Chimp, etc.). If not, we can purchase the subscription as a direct expense. CD&P will utilize suggestions from the Board and the Communications Committee to newsletter stories.

Deliverables: content creation and design of up to 4 newsletters including 2 rounds of revisions, and up to 6 hours of photography

ATTENDANCE AT BOARD MEETINGS

CD&P will work with staff and the Board to identify which board meetings we should be attending or getting highlights from the recorded meetings. This budget accounts for 36 hours of attendance/reviewing recorded meetings.

Deliverables: up to 36 hours of attendance/review of meetings

CONTRACT ADMINISTRATION & MANAGEMENT

CD&P will administer and manage the contract including setting up coordination meetings with staff and build out of an annual schedule. Invoices will be developed no more frequently than monthly and are due net 30 days.

FEE SCHEDULE

We have provided a range of rates to provide the best value. One of our strengths is supporting and supplementing our clients' staff and having full team commitment to respond to client needs. This proposal has been prepared to assist the Block House Creek MUD Board with communications. This is a time and materials contract and only time expended and expenses incurred will be billed. 


